### RETURNED GOODS POLICY

Product returns are subject to Merry X-Ray/SourceOne's standard return policy. Merry X-Ray/SourceOne does not allow returns on the following:

- (1) any products not purchased from Merry X-Ray/SourceOne;
- (2) any special or unique goods and any products purchased on a special order basis (this includes custom products and special order films, as designated by the film manufacturer);
- (3) any chemicals, cassettes, screens, grids, diagnostic materials, needles, syringes or sterile products (unless defective or covered under manufacturer's warranty);
- (4) equipment or single-use products already used, already outside of original packaging, or separated from original labeling and operating manuals;
- (5) any products that have been opened or damaged, or have missing or defaced labeling or packaging;
- (6) any products within nine (9) months of the expiration date as noted on the packaging; and
- (7) any products directly shipped from the manufacturer, unless Merry X-Ray/SourceOne can obtain a Return Authorization from the manufacturer prior to issuing a Return Sales Order to the Customer.

Credit will not be issued for product after 60 days from date of invoice.

All returned goods must be received at Merry X-Ray/SourceOne's local Distribution Center within thirty (30) days of the Return Sales Order date to be eligible for full or partial credit.

All returns are subject to a restocking charge of 25 percent (25%) of the original invoiced price except (a) goods damaged in shipment and (b) returns due to Merry X-Ray/SourceOne mis-pick.

The Customer is responsible for all freight and insurance in returning any products to Merry X-Ray/SourceOne. If the Customer is unable to return the product, and Merry X-Ray/SourceOne is responsible for pickup of returned goods, a thirty percent (30%) restocking fee of the original invoiced price will apply.

It is understood that Customers will comply with all special packaging and labeling requirements of Merry X-Ray/SourceOne, consistent with applicable law and regulations.
